SUBSTANTIATION OF THE RELEVANCE OF STUDYING THE SELF-ACTUALIZATION OF MATURE MEN HELD IN PRE-TRIAL DETENTION CENTERS

Abstract. The article shows the prospects of applying the theory of selfactualization in order to increase the effectiveness of the resocialization of the special agent of the penal system. The results of solving three research problems are presented. In accordance with the first task, the concepts of self-actualization are analyzed and the need for scientific research on the self-actualization of the special agent of the penal system according to the stages of legal relations of the individual is argued. In accordance with the second task, the results of an empirical study of the features of self-actualization of mature men who were first detained in a pre-trial detention center are presented. The sample included 360 people divided into two groups - a group of men who had previous convictions, but had no experience of staying in a pre-trial detention center, and a group of men who had no previous convictions. The method of "SAT" by E. Shostrom was used. The hypothesis of the existence of differences in the self-actualization of men was tested. It was found that a number of indicators of self-actualization of previously untried and convicted men significantly differ (the value of self-actualization, spontaneity in expressing their feelings, contact, creativity, sympathy for people, flexibility of behavior, self-esteem, synergy, acceptance of their own aggression, cognitive needs). In the group of previously convicted men, all indicators for which differences have been established are at a higher level, with the exception of sympathy for people, it is significantly higher in the group of previously convicted men. The obtained data were compared with the data of other authors, which allowed us to come to the conclusion that the process of self-actualization becomes more complicated at each subsequent stage of legal relations of the individual. In accordance with the third task, the results of the search for the connection of self-actualization with other personality characteristics are presented, as well as a model of an empirical study of the personal determinants of self-actualization of mature men detained in a pre-trial detention center. As a result, it is proposed to include in the algorithm of the psychologist's work to determine the degree of correction of the convicted person an assessment of his self-actualization, which it can serve as a marker of the process of re-socialization at each of the six stages of legal relations of the

individual. The prospect of further scientific research on the self-actualization of the special agent of the penal system is shown.

EXPERIMENTAL STUDY OF VOLITIONAL QUALITIES OF PERSONALITY IN PSYCHOLOGY

Abstract. The article identifies the problems associated with difficulties in the study of the volitional sphere of personality, as well as in the construction of a classification of methods and the main common techniques; examples of natural and laboratory experiments of the representative of the Ryazan School of Will, Professor I. I. Kuptsov, are given. The purpose is to reveal the features of the application of the method of experimental study by E. I. Ignatiev of the stimulation of volitional efforts on the example of juvenile male convicts. The general theoretical methods of scientific cognition, the method of system and logical analysis, statistical method, information and analytical method, methods of cognition, analysis and synthesis, experimental, psychodiagnostic methods were used. The results that were obtained by the authors during a laboratory experiment using a dynamograph - a dynamographic technique for studying an arbitrary delay of maximum muscle contraction are disclosed. The experiment included three series with the participation of juvenile convicts serving sentences in educational colonies. The effectiveness of the use of methods of stimulating volitional efforts in overcoming difficulties has been experimentally proven.

Abstract. The article deals with the problem of negative emotional states among police officers caused by the peculiarities of professional official activity and the ongoing global changes in society caused by the new coronavirus infection (COVID-19). The authors actualize the problem of timely diagnosis and regulation of negative emotional states in police officers. This requires an algorithm of actions, which includes three stages. At the first stage, the diagnosis and assessment of the emotional states of employees is carried out. In particular, the authors suggest using the scheme developed by them for monitoring the external manifestations of stress at various levels, a conversation with a choice of emotions and a methodology for studying well-being, mood, activity. The article presents the materials and methods of their study, as well as interprets the results obtained – the presence of a high level of stress in the majority of respondents. The second stage involves the compilation of group emotional portraits based on the obtained research data and, in accordance with this, the development of specific recommendations for each group. The article emphasizes the importance of the results obtained for the development of practical recommendations and direct psychological assistance to police officers. The third stage is the work aimed at creating general recommendations for specialists in psychological support of employees. In addition, at this stage there is direct psychological assistance for the regulation of negative emotional states. The authors suggest using the Sedona method (release of emotions), which helps to understand what emotions are talking about and how to manage them, promotes energy, gives strength, improves well-being and mood.

PROGNOSTIC MODEL OF SUCCESSFUL ADAPTATION TO PROFESSIONAL ACTIVITY OF EMPLOYEES OF INTERNAL AFFAIRS BODIES

Abstract. The article considers the issues of adaptation to the professional activities of employees of internal affairs bodies during the period of professional training as one of the important areas of psychological work. The effectiveness of further professional activity of a young employee depends on the possibility of predicting the success of adaptation. The author substantiates the development of a predictive model of the success of adaptation to professional activity of employees who are first employed in the internal affairs bodies undergoing vocational training. Cluster and discriminant analysis was used to develop a predictive model of the success of adaptation to the professional activities of law enforcement officers. Using cluster analysis based on subjective and objective criteria, groups of employees with high and low levels of success in adapting to professional activity were identified. By means of discriminant analysis based on individual psychological and socio-psychological characteristics of the personality of employees of the internal affairs bodies, a highly informative predictive model of the success of adaptation to professional activity of employees who are first employed in the internal affairs bodies undergoing vocational training has been developed (Wilkes' λ : 0.406, p < 0.0000). Predictors of the success of adaptation to the professional activities of ATS employees are indicators of behavioral regulation, emotional stability, anxiety, sensitivity, integration of lifestyles, complexity of the task, the dominant state - the stability of the emotional tone, assessments of the experience gained, interaction in society, one's own opinion. Employees with a high level of successful adaptation to professional activity are characterized by a high level of neuropsychic and emotional stability, an adequate perception of reality, motivation to perform complex tasks, balance of various aspects of life, a positive assessment of the experience gained in the course of professional activity, a sense of attention from the team and management to themselves and the results of their activities, reasonableness, preservation of effective mental self-regulation of behavior and activity in a state of emotional arousal. A psychodiagnostic algorithm for the application of a predictive model is presented, which is advisable to use in the framework of psychological support of professional activities of employees both at the stage of professional training and during the performance of operational and service tasks.

SOME PSYCHOLOGICAL FEATURES OF MINORS WITH ILLEGAL BEHAVIOR SENTENCED TO PROBATION

Abstract. The article describes the results of an empirical study of minors with illegal behavior sentenced to probation. The empirical study was conducted in four stages: 1) two samples were formed: the first group - minors, conditionally convicted, the second group - law-abiding students of secondary school; 2) an empirical study of groups of samples was conducted using the following psychodiagnostic techniques: "Kettell's 16-factor personality questionnaire (form C), "Morphological test of life values" (V. F. Sopov, L. V. Karpushina), "Diagnostics of socio-psychological adaptation" (K. Rogers), the method of "Readiness for risk" (G. Schubert), the method of "Life orientations" of the SOHO (D. A. It is established that minors with illegal behavior, conditionally sentenced to imprisonment, are characterized by the following manifestations of psychological characteristics: weak self-control of emotional reactions, sociability, emotional instability, risk-taking, aggressiveness, tendency to cruelty, low self-control, lack of activity planning, suspicion, conflict, unbalance, conservatism. With the help of factor analysis, the factors that make up the structure of personality were identified: life benefits, adaptation, cognitiveness, conformity, meaningfulness of life.

Abstract. The article describes the process of developing and testing a questionnaire of criminal infection of juvenile suspects, accused and convicted by employees of the interregional Department of psychological work of the Federal Penitentiary Service of Russia in the Sverdlovsk region on the instructions of the Department of educational, social and psychological Service of the Federal Penitentiary Service. The methodology consists of 28 points and includes 6 scales: "Cognitive component", "Emotional component", "Behavioral component", "General level", "Lie scale" and "Response Consistency Scale". 23 educational colonies, 122 pre-trial detention centers and premises functioning in the mode of a pretrial detention center, 78 criminal enforcement inspections participated in the testing of the methodology. In total, the study covered 3,609 minors, including 959 convicted of educational colonies, 875 juvenile suspects, accused, convicts held in pre-trial detention centers, 1,775 minors registered with the penal enforcement inspectorate. The technique makes it possible to screen the level and structure of criminal infection of minors, the initial construction of a plan of work with suspects, accused, convicted.

THE INTERACTION OF THE INVESTIGATOR AND THE PSYCHOLOGIST IN THE CRIMINAL PROCESS

Abstract. Within the framework of this article, the authors set the task to consider the actual problems of the investigator's interaction with such a participant in the criminal process as a psychologist. Criminal procedure and forensic science, as well as legal psychology, analyze in detail the issues of the status of the central participant in the preliminary investigation - the investigator. Studying the functions, role, significance of the investigator as a participant in the criminal process, the authors also touch upon the problems of interaction with other participants, first of all: interrogators, the head of the investigative body, suspects, witnesses. Currently, insufficient attention is paid to the problems of a psychologist in investigative and procedural actions. The psychologist is actually an inferior participant in the criminal process. There is no definition of the concept of "psychologist", clearly defined rights and obligations. In fact, performing the functions of a specialist, a psychologist, according to the authors, could play a more significant role in the criminal process. Through the prism of comparing the knowledge gained in the framework of criminal procedure and legal psychology, the authors propose to supplement art. 5 The Criminal Procedure Code of the Russian Federation defines the concept of "psychologist", expand the range of procedural and investigative actions in which a psychologist can take part; introduce full-time psychologists to work in investigative bodies; increase the number of forms of interaction between an investigator and a psychologist and increase the level of professional training of future investigators in the field of studying methods of interaction between an investigator and a psychologist.
